1989 System Dynamics Conference

This years Conference was held at the University of Stuttgart in West Germany and was organised by Erich Zahn and Peter Milling. This was a great success and those members of the Society who did not attend missed both good papers and convivial company. My personal thanks to all those involved with the organisation.

I would also like to thank those members of the Policy Council of the Society who attended the conference and who sat through many hours of meetings to further the cause of the Society. In particular I would like to mention Bob Eberlein who so diligently took the minutes in all these meetings.

Future Conferences

The 1990 System Dynamic Conference will be held in Boston Massachusetts from 10th to 13th July. Abstracts of papers for this were due on the 1st November 1989 and full papers should be submitted by the 15th April 1990. At the Stuttgart meeting the Policy Council of the Society gave considerable thought to a longer term strategy for Conferences beyond 1990.

In 1991 it was decided to deviate from the normal pattern of alternation between American and European sites. Consideration was given to locating the conference in India and Thailand, both of whom have been instrumental in developing the subject. The final decision was made in favour of Thailand and the Asian Institute of Technology in Bangkok will host the 1991 Conference.

Subsequent conferences will revert to the normal European/American sequence. It is now Society policy that Conference sites should be chosen two years in advance on the basis of formal proposals. A paper outlining the required format for proposals is available from the Principal Office.

In 1992 the International Conference will be held in

Europe. Proposals from sites interested in holding this conference should be submitted to the Society's Principal Office by the 31st December 1989. Two cities have so far shown interest in holding this conference. These are Milan and Utrecht.

The 1993 Conference will be held in America and the 1994 in Europe. Proposals for these events should be made at the latest by 31st December 1990 and 1991 respectively.

Chapters of the Society

Developments have taken place to finalise the rules by which the Chapters of the Society can be formed and the Society is in the process of finalising the formal relationship between itself and the Italian Chapter.

In future, the Chapters of the Society will be represented at the Policy Council by a non voting member. The person so designated by the Chapter will be able to sit on all Policy Council meetings and receive the minutes of those meetings.

Society Dues Structures

From next year there will be a two tier dues structure. Full members will be charged U.S. \$60 whilst students and persons whose self assessed gross family income is less than U.S. \$20,000 per year will be charged U.S. \$30 per year.

The organisers of the 1990 Conference in Boston will be considering a differential conference fee for Society members.

Society's Finances

The finances of the Society are basically sound and this is in no small way due to the efforts of Jack Pugh in his role as Vice President, Finance. A small cash surplus is expected for 1989 and there is some scope to spend this on selective items. The Society does, however, still require to generate further sponsorship and all members are requested to pursue this matter in their home countries.

Membership of the Society

Membership of the Society is reasonably steady with sufficient new recruits being made to balance those leaving. Apart from encouraging further members it is important for the Society to understand the cause of the attrition rate and to reduce it.

A Membership Directory is now available and this

will facilitate the analysis of trends in the membership.

System Dynamics Review

The journal is developing well and there is currently a very healthy surplus of papers awaiting publication. The lead time for publication of papers is now approximately two years. The quality of papers is also increasing. Congratulations are in order to George Richardson and his team for creating this sound situation.

To accommodate the backlog of papers the average size of each issue will be increased from 100 to 120 pages. This increase will be funded from the Society's surplus revenue. Further expansion of the journal to three issues per year will be kept under review.

Mike Radzicki is promoting the journal in other journals through shared advertising.

The Department of Peace Studies at Notre Dame has sponsored a \$1,000 prize for articles in the journal dealing with peace and nominations for this prize should be sent to:

Nominations must be made in writing by a member of the Society and must be supported by a signatures of 9 (nine) additional members in good standing. The total of ten members signatures may accompany the nomination letter or the signatures may arrive in separate letters of support. In any event, the nomination and at least ten valid signatures must be received at the principal office of the Society no later than May 15th 1990.

If alternatives are nominated, a ballot will be mailed to all members by early June 1990, to be returned by 30th June 1990. Election results will be announced at the 1990 Conference in Boston and in subsequent issues of the President's letter.

Gordon S. Brown Fund

A \$200,000 fund has been established by Gordon S. Brown to stimulate the teaching of System Dynamics in primary and secondary schools. The primary objective is to help train teachers in the use of system dynamics. This is a very generous initiative and the Society will take charge of the administration of this fund and organise an investment and award committee to manage it.
