The System Dynamics Review

The editors of the *System Dynamics Review* have decided to expand the special issue on mathematical chaos into a double issue (Volume 4, Numbers 1 & 2). The issue, edited by Erik Mosekilde, Javier Aracil, and Peter Allen includes introductory articles on the basic concepts of chaotic dynamics, notes on simple models and teaching exercises as well as reports on work at the frontier of research into complex dynamics in nonlinear systems.

The double issue on chaos will be more than twice as large as previous issues of the *Review* and will be the only one mailed in 1988. The regular pattern of two issues per year will resume with Volume 5, Number 1 in the winter of 1989.

Several members have begun organizing chapters of the Society. Chapters are regional subgroups of the Society based on geographic divisions. Colleges are non-geographic interest groups. The rules governing chapter and college subdivisions are relatively simple:

- A subdivision shall have a nonprofit purpose substantially similar to that of the Society: Furthering research, teaching or application of the principles of feedback systems to human endeavor.
- A subdivision shall have at least ten members.
- All members of a subdivision shall be members of the System Dynamics Society.
- Membership in a subdivision shall be open to all members of the Society.
- Subdivisions are administratively separate from the Society and may not obligate the Society legally or financially.
- The name of the Society and subdivisions may not be associated with any commercial product or service.
- Subdivisions must be officially recognized by the Policy Council.
